NOTICE OF INTENT OF SECTION 116(3)(a)(b)(i) &(ii) PROCESS TO AMEND THE APPOINTED CONTACT: CCLM/016/2020/21T

Notice is hereby given in terms of Municipal Finance Management Act (56 of 2003) Section 116 (3a) & (3b) (i) &(ii) which state that a contract or agreement procured through the supply chain management policy of the municipality or municipal entity may be amended by the parties, but only after— (a) the reasons for the proposed amendment have been tabled in the council of the municipality or, in the case of a municipal entity, in the council of its parent municipality; and (b) the local community— (i) has been given reasonable notice of the intention to amend the contract or agreement; and (ii) has been invited to submit representations to the municipality or municipal entity.

Kindly be notified that Collins Chabane Municipality intends to amend the contract entered with FJRIC Construction for the Construction of Mahatlane Access Bridge: CCLM/016/2020/21T. The reasons for the proposed amendment were tabled and approved by the Council in its 55th SPECIAL COUNCIL MEETING held through virtual (WEBEX) at 11H00 on the 27TH AUGUST 2021 - ITEM A08/27/08/2021 Bid CCLM/016/2020/21T Mahatlane Access Bridge.

The amendment to the contract will be as follows: Additional 2880sq of 80mm brick paving, Additional 120m³ of Class (25/19) concrete, Additional 50m of sub-soil drainage and Additional 500 Pre-cast mountable kerb (Fig 3). The cost for the amendment will be R1,339,827.20 (Vat Excl.)

Given the background above, the public is invited to submit written comments or representations within 7 working consecutive days from the date of publication which is Monday 06th September 2021 until Tuesday the 14th September 2021, to the office of the Municipal Manager in respect of the proposed amendment. Such comments or representations must be submitted into the SCM tender box at Collins Chabane Local Municipality Malamulele Civic Centre.
